

OFFICE OF BEHAVIORAL HEALTH—PREVENTION SERVICES State Fiscal Year 2013 Report

The Office of Behavioral Health (OBH) is committed to providing quality, cost-effective prevention and treatment services. In an effort to demonstrate accountability and transparency, OBH Prevention Services has developed this report to capture prevention services provided through funds of the prevention portion of the Substance Abuse Prevention and Treatment (SAPT) Block Grant. The SAPT Block Grant is the primary funding stream for prevention services in our agency. It requires twenty (20%) percent of the Block Grant be set aside for primary prevention services.

An important issue for prevention services is consumer confidence and transparency of our use of available resources. It is our challenge to be efficient in the use of these resources. This report is a continuing process to measure the number of services we provide and the populations that are served.

The data in this report is from the Prevention Management Information System (PMIS). PMIS is the primary reporting system for the SAPT Block Grant for prevention services. Data and information outlined in this report are also used to meet the requirements for the following National Outcome Measures (NOMS):



ENROLLEE REGISTRATIONS

The Office of Behavioral Health Prevention Services target for SFY 2013 is to serve 72,738 enrollees in evidence-based programs at an average cost of \$54.16 per enrollee. During State Fiscal Year 2013 (July 1, 2012-June 30, 2013) Prevention Services provided evidence-based services to 88,030 enrollees (121% of target). This is an average of 8,803 per Region, District and/or Authority. Please note this average is not a target or Louisiana Performance Accountability System (LAPAS) indicators, simply an average of the registrations of enrollees during the time frame measured.

During State Fiscal Year 2012 (July 1, 2011-June 30, 2012) Prevention Services provided evidence-based services to 77,078 enrollees (106.5% of target 72,358). Through the State Fiscal Year 2011 (July 1, 2010-June 30, 2011) Prevention Services provided evidence-based services to 77,171 enrollees. This represented a 7% increase over SFY 2010 (72,095). During State Fiscal Year 2010 (July 1, 2009-June 30, 2010) Prevention Services provided evidence-based services to 72,095 enrollees. This represented a 26% increase over SFY 2009 (57,342). During State Fiscal Year (SFY) 2009 Prevention Services provided evidence-based prevention services to 57,342 enrollees. During State Fiscal Year (SFY) 2008 Prevention Services provided evidence-based prevention services to 29,291 enrollees. This represented a 172% increase over SFY 2007 (10,400).


This increase in service delivery is due to our partnership with the Department of Education, the mobile service delivery model, cost bands for evidence-based programs and fee for service contracts. This partnership allows us to provide services directly to the youth population while utilizing the Department of Education's infrastructure. This reduces our infrastructure cost and allows those resources to be moved to direct services. The cost band for universal (\$75.00 or less), selective (\$100.00 or less) and indicated (\$150.00 or less) programs help us keep our cost down based on the actual cost of service delivery for specific programs. This is based upon the program developer's information on training cost, curriculum cost, labor cost, and evaluation cost per enrollee. The fee for service contracts allow Prevention Services to only pay for services rendered. These improvements allow Regions, Human Services Districts or Human Services Authorities to reduce their cost per service while providing quality evidence-based prevention services to more students, in more parishes, without additional resources.

The majority of these services fall under the CSAP Education Strategy. This strategy involves two-way communication and is distinguished from the Information Dissemination Strategy by the fact that interaction between the educator/ facilitator and the participants is the basis of its activities. Activities under this strategy affect the life and social skills, including decision-making, refusal skills, critical analysis (e.g., of media messages), and systematic judgment abilities. Examples of the most common education curriculum programs used by our providers are Life Skills, Project Northland, Positive Action, Coping Skills, and Project Alert.

Another important strategy used in providing these services is to identify those who have indulged in age-inappropriate use of tobacco or alcohol and those who have indulged in the first use of illicit drugs to ascertain if the behaviors can be reversed by education. It should be noted this is not to be used to determine if a person is in need of substance abuse or treatment services. Substance Abuse prevention literature is available free of charge to the public, schools, and/or any other interested group.

During SFY 2013 the Office of Behavioral Health Prevention Services had a total of fifty six (57) providers. Forty six (46) are Community-Based Prevention Providers and ten (10) are Synar contractors. The forty six (46) Community-Based Prevention Providers are providing a total of fifteen (15) programs.






SYNAR UNCONSUMMATED COMPLIANCE CHECKS

In 1992, Congress passed the Synar Amendment to the Alcohol, Drug Abuse and Mental Health Administration Reorganization Act. The Synar Amendment, named after its congressional sponsor Mike Synar, requires States to develop laws reducing the sale and distribution of tobacco products to individuals under the age of 18. The law was based upon research evidence that nearly 90% of adult smokers began smoking before the age of 18 and that they regularly purchased their own cigarettes from stores and vending machines. In 1997, state baseline violation rates ranged from 7.2% to 72.7%, with an average rate of 40.6%. Federal actions were taken to move all states to less than 20%. States that fail to comply with the amendment risk losing between 10 and 40% of Federal block grant funds allocated for substance abuse prevention and treatment. It is important to note that Louisiana, which had the highest violation rate in the nation at baseline in 1997, has been recognized for reaching and maintaining a non-compliance rate below 10%.

During State Fiscal Year 2013, there were 4,457 SYNAR unconsummated compliance checks recorded in the PMIS system from the Regions, Human Services Districts and Human Services Authorities. Of the 4,457 retailers 4,176 unconsummated compliance checks were completed. Of these 3,812 (91.3%) were unwilling to sell, 364 (8.7%) were willing to sell. Our target by the end of April is 200 unconsummated compliance checks and another 200 during May and June for a total of 400 for the fiscal year in each Region, Human Services District or Human Services Authority.
